Some Common Challenges of Disposition Approvals


- Sending out the correct records to the appropriate approvers
- Getting people to do them!
- Taking action on the records once people have competed their review





Sending out the correct records to the appropriate approvers

- Use a single Disposition Search to create multiple RDA packages
- Use facets (metadata) and filters to help create the packages







Getting people to do them!

- The easier and more efficient you make it for users to review the records, more likely they will perform the disposition review
 - Ability to request feed back from other users
 - Use facets and filters to bulk approve/reject records
 - The "Consolidated view" allows users to see all pertinent metadata
 - Customers report users only needing 20 minutes of training to use RDA!

 No need to add records to Collections, or Accessions, or try to locate them with searches. With RDA you can take action on the records directly from the RDA interface!
